

PIER USAGE RULES LOS ANGELES YACHT CLUB MEMBERS

FLAG CODES:

November Flag – No tie-up or passenger pick up/drop off.

Charlie Flag – Passenger pick up/drop off allowed subject to the rules below.

LAYC Burgee – Tie-up allowed by LAYC members at the designated area.

By using the pier at Howlands Landing, the LAYC member(s) and the member's guest(s) agree to hold harmless Catalina Island Camps, its employees, officers and agents, from and against any and all damages, liabilities and claims, costs, expenses, attorney's fees, etc., incurred by the member(s) or the member's guest(s) directly or indirectly in connection with the use of the pier. The LAYC member(s) and the member's guest(s) agree to release CIC from all liability from any use of the pier including, but not limited to, docking, transferring from boat to dock or vice-versa, or moving on floats, gangways and fixed piers.

FOR PIER AND CAMP USAGE, LAYC AND ITS MEMBERS AGREE TO THE FOLLOWING CONDITIONS:

- LAYC Members and their guests are to move directly from the pier to Frog Rock. If you wish to access the road, please use the traditional route on the east side of camp.
- Members will be responsible for their guest(s) and agree to fully inform them of these conditions.
- Members and their guests are not to loiter on camp property, the pier, dock, floats or shore between Frog Rock and the pier.
- Dinghies are to be 16 feet or less in length.
- All dinghies will be bow tied by a single line. Do not bow and stern tie your dinghy.
- No overnight tie-up allowed.
- While on camp property, dogs must be kept on a leash and held by an adult. Any waste will be picked up and disposed of by owner.
- Do not litter on camp property. Do not leave any trash in trashcans at camp or on the pier. Remove all trash to your boat and dispose of on the mainland.
- Smoking is not allowed on the dock, pier, landing or other camp property.
- No open containers of alcoholic beverages, including cans, bottles, plastic cups or glasses. Any alcohol carried across camp property must be non-recognizable by campers, staff or directors of CIC.
- LAYC members may not use any camp equipment or property other than to tie-up a dinghy or walk to Frog Rock.
- Use caution whenever landing, loading or unloading boats.
- LAYC will be notified of person or persons who violate these rules. CIC will expect LAYC to handle these matters effectively and immediately.

DETAILED PIER USAGE INSTRUCTIONS:

Picking Up/Dropping Off Passengers:

- Whenever possible, pick up/drop off should take place on the west side of the dock or in the designated tie-up area.
- Pick up/drop off of passengers may occur at any time, **except for the following:**
 - ♦ **“November” Flag** – No tie-up, and no passenger pick up/drop off (per CIC).
 - ♦ **Catalina Express** – When the camp is actively loading or unloading the Catalina Express (or other similar passenger charter boat) and approximately 30 minutes before and after the Catalina Express (or other similar passenger charter boat) lands at the pier, so that camp staff can move luggage between dock and shore unencumbered.
 - ♦ **Between Memorial Day and Labor Day** - Dinghies wishing to pick up/drop off passengers should stand off whenever campers are landing, launching, or loading.

Dinghy tie-up at the designated portion of the dock

- **Prior to Memorial Day** - tie-up will be allowed on the west side of the large main float.
- **After Memorial Day** - the camp will install its ‘L’ section parallel to the shore and the outside length of that dock will be available for tie-up.
- **After Labor Day** - the camp will remove the ‘L’ section and tie-up will return to the west side of the main float.
- **Between Memorial Day and Labor Day** - at the conclusion of daily summer camp waterfront activities (approximately 5:30 pm, however times may vary), LAYC members may tie-up their dinghy at a designated portion of the dock subject to the following:
 - ♦ When necessary, CIC reserves the right to withhold float availability for dinghy tie up. CIC will give LAYC prior notice of such rare occurrences.
 - ♦ CIC will fly the LAYC burgee when it is clear to tie-up on the dock.
 - ♦ No tie-up should take place on the east side of the dock, except for less physically able members as described below.

Prior to Memorial Day and after Labor Day

LAYC members may tie-up to the designated portion of the dock whenever the “Charlie” flag is flying.

Handicapped Access to Dock

- Whenever the “Charlie” flag or LAYC burgee is flying, limited tie-up space is available (one or two dinghies) for less physically able members of LAYC. Members may unload wherever they like but we request they tie their dinghy at the inside portion of the east side of the dock closest to shore.
- LAYC and CIC will determine a method to identify members who may tie-up on the dock at any time.

LAYC WILL BE NOTIFIED OF PERSON OR PERSONS WHO VIOLATES THESE RULES AND REGULATIONS. CIC WILL EXPECT LAYC TO HANDLE THESE MATTERS EFFECTIVELY AND IMMEDIATELY.
